IN ORDER TO RESERVE AN EVENT DATE, a minimum payment of TWENTY FIVE PERCENT (25%) of TOTAL USE FEE MUST BE PAID AT THE TIME THIS AGREEMENT IS SIGNED. If the event is cancelled, the amount of the refund will be determined as follows: cancellation more than ninety (90) days prior to the event date, one hundred percent (100%) of reservation and use fees previously paid will be refunded; cancellation between ninety (90) days and forty-five (45) days prior to the event date all fees previously paid will be forfeited; cancellation less than forty-five (45) days of the event date, a penalty of \$250.00 will be assessed by the CITY. THE TOTAL SPRINGDALE DAMAGE DEPOSIT of FIVE HUNDRED DOLLARS (\$500) MUST BE PAID IN FULL AND RECEIVED BY THE CITY seven (7) days prior to the Event date (\_\_\_\_\_\_ SPRINGDALE Damage Deposit is not received by the payment date specified above, the CITY OF ANDALUSIA will immediately release the reserved premises for use on the reserved date by another party and the Use Fee penalty stated above will be assessed and retained by the CITY accordingly. All received Damage Deposit(s) will be held by the CITY and returned to the USER IF NO DAMAGE OCCURS. THE CITY WILL ASSESS THE SPRINGDALE PROPERTY IMMEDIATELY FOLLOWING AN EVENT TO DETERMINE THE DAMAGE DEPOSIT REFUND.
